### 1. Introduction

Heartland Coalition for the Homeless (HCH) is requesting proposals from qualified organizations and partners to support activities under the 2025 Notice of Funding Opportunity (NOFO) for HUD Continuum of Care Program.

The purpose of this RFP is to identify projects that advance HCH's mission to prevent and end homelessness through evidence-based, person-centered, equitable strategies.

# 2. Funding Opportunity Overview

- Maintain proper financial controls and administrative capacity.
- Participate in the local Continuum of Care (CoC) processes.
- Comply with HUD regulations, Housing First principles, and equitable service delivery standards.

Late or incomplete proposals will not be reviewed.

### B. Housing First & Equity (1-2 pages)

- · How barriers (ID, sobriety, income) will be minimized
- Culturally responsive and trauma-informed approaches
- Strategies to reduce racial disparities

### C. Performance Outcomes (1-2 pages)

Provide measurable goals, including:

- Housing placement rate
- · Housing retention
- Utilization rate
- · Length of time homeless
- · Returns to homelessness

### D. Organizational Capacity (1 page)

- Experience with HUD or federal programs
- Staff qualifications
- Financial and administrative management

### E. Partnerships & Coordination

- Coordination with CE
- MOUs with service/housing partners
- Collaboration with healthcare, DV agencies, etc.

# 6. Budget Requirements

Applicants must submit:

- Line-item budget
- Budget narrative
- Match requirements (if applicable)
- Indirect cost documentation (if using approved rate)

Cost must be reasonable, necessary, and allowable under federal cost principles.
